PLEASE NOTE THE FOLLOWING: In general, membership is restricted to one or more adult members of a household and ownership or lease of a Land Rover or Range Rover 4 Wheel motor vehicle. To apply for membership, you must submit a complete, signed membership form and agreement, and your check for one year of membership dues. Membership dues are paid annually in advance and not refundable, unless membership or renewal is not approved.

To attend any Club on- or off-road event, you must have in force the following minimum liability insurance coverage, which must not contain any off-road exclusions.

Auto Property Damage coverage of at least \$100,000

Auto Liability coverage of at least \$300,000

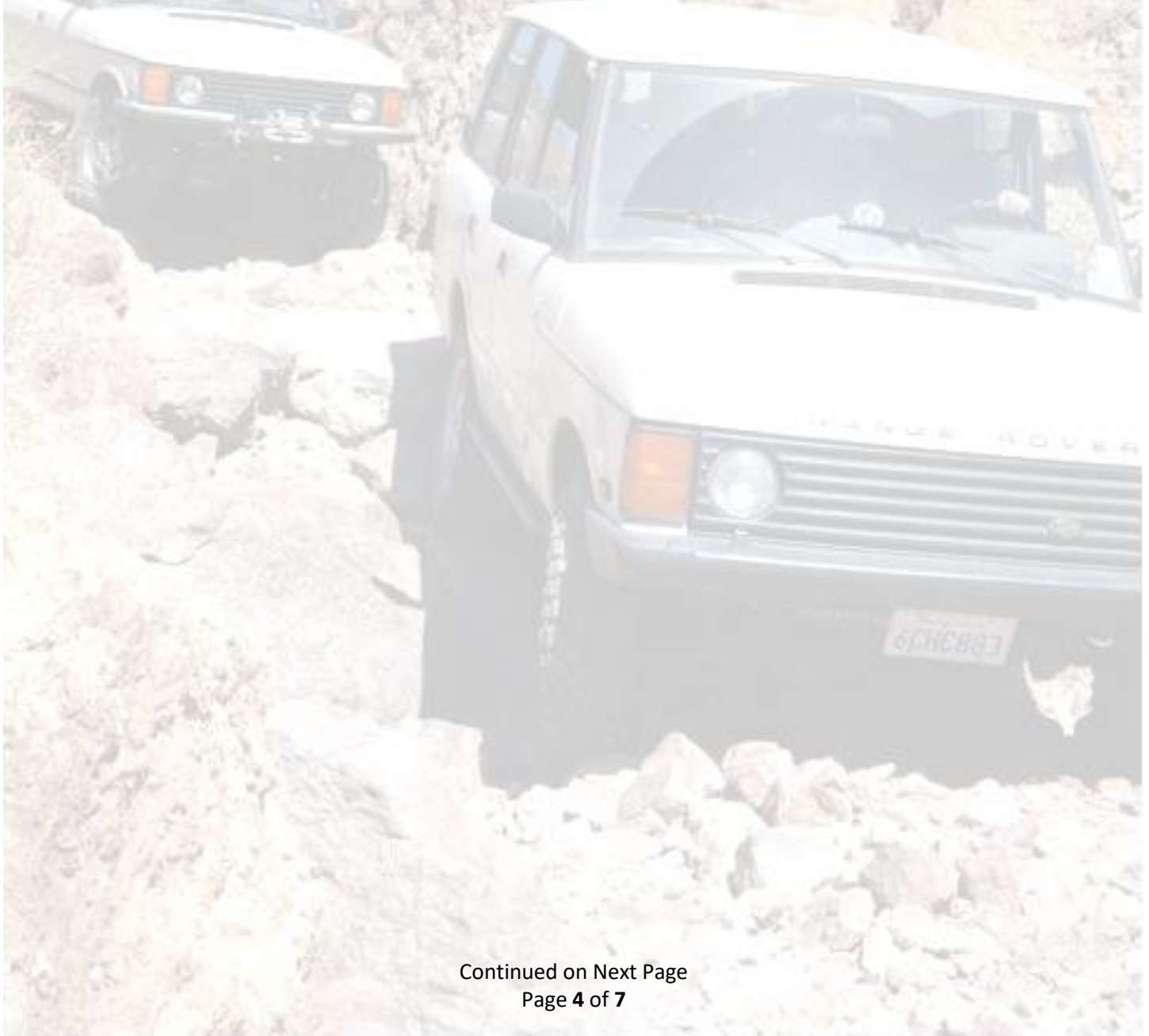

MEMBER AGREEMENT, IDEMNITY & RELEASE  
(the *Agreement*)

**NOTICE: YOU ARE GIVING UP IMPORTANT LEGAL RIGHTS.  
PLEASE READ THIS DOCUMENT, AND CONSULT WITH YOU LAWYER BEFORE DECIDING TO SIGN.**

**CLUB EVENT PROCEDURES**

In order to protect the Club and its Board of Directors, officers, guides, trip leaders, spotters, and other designated representatives (individually or collectively in their respective capacities as Club representatives, the *Club Officials*), the attendance or participation of a member at any Club event, including, without limitation, on-road and/or off- road events and travel to and from those events (an *Event*), is conditioned on the Club's prior receipt of the flowing signed documents: (a) this Agreement signed by the members attending the Event; (b) if the Club requires, a written, signed reaffirmation of this Agreement; (c) for each non-member adult guest (age 18 or over), a signed Adult Guest Agreement, Indemnity and Release (*Adult Guest Agreement*); and (d) for each minor guest (under age 18) who is not the minor child of a member who attends the Event, a Minor Guest Agreement, Indemnity and Release (*Minor Guest Agreement*) signed by the adult parent or legal guardian of each attending minor guest and by a custodial adult who assumes care, custody and control of each minor guest during the Event.

**AGREEMENT**

We, the undersigned adult Club members, jointly and severally, for ourselves, and for our adult and minor children, estate, heirs and personal representatives (collectively *we, our, or us*), agree for the benefit of the Club and Club Officials, as follows:

**1. Events.** This Agreement applies to each and every Event we choose to attend. The Club has the right, but not the obligation, to determine who may or may not attend or participate in an Event, including, but not limited to, members, guests, and vehicles.

**2. Risks, Voluntary Participation, Risk Assumption.** We agree that our attendance at or participation in an Event may be dangerous and involve foreseeable or unforeseeable risks, including, without limitation, mechanical failures, first aid, or negligence by us, our guests, the Club, Club Officials, other members of the Club (*Other Club Members*) and/or other third persons; and that such risks could result in injury or death and/or damage to property. Our decision to attend and/or participate in any aspect of an Event is voluntary and by our attend attendance and/or participation we hereby assume all such risks.

**3. Release of Claims.** *Released Claims* means any and all claims, causes of action, demands, damages, injuries, rights, liabilities, and/or losses, including, without limitation, active or passive negligence of the Club and/or Club Officials. We hereby waive, release and forever discharge the Club and Club Officials, from and against any and all Released Claims, whether known or unknown and whether past, present or future, that arise, directly or indirectly, from, or in any manner associated with each Event that we attend or participate in. With respect to such Released Claims, we waive and relinquish, to the fullest extent permitted by law, the benefit of California Civil Code § 1542, which provides:

“A general release does not extend to claims which the creditor does not know or suspect to exist in this favor at the time of executing the release which if known by him must have materially affected his settlement with the debtor.”

**4. Indemnity.** We hereby agree to indemnify, defend, and generally hold harmless Club and Club Officials, rights, from and against any and all claims (including the Released Claims), causes of action, demands, damages, injuries, rights, liabilities, and/or losses (including legal fees and expenses) that arise directly or indirectly, from, or are in any way related to or caused by our act, omission, negligence, and/or willful or intentional misconduct at any Event.

**5. Insurance.** At all times during each Event we attend or participate in, we will have in full force and effect liability insurance with liability limits of not less than (a) \$300,000 for bodily injury, and (b) \$100,000 for property damage. Our insurance will contain no off-road or similar exclusions, will cover us and all other persons who operate our vehicle(s) with our written or oral permission, and will neither limit our above release, nor limit our indemnity, defense, and other obligation under this Agreement.

**6. Minor and Adult Guests.** If we bring minor or adult guests to an Event, we agree that neither we nor our guests may attend or participate in the Event if the Club has not received a signed Adult Guest Agreement and/or Minor Guest Agreement before the Event starts.

**7. Club Rules.** We agree to comply with all published Club rules adopted by the Club’s Board that are in effect from time-to-time. (A copy of the Club rules may be obtained from the secretary of the Club).

**8. Photo Release.** Subject to the provisions of this paragraph, the Club reserves the right, and grants to Club Officials and Other Club Members the right, to take photographs or video records of any Club Event. We agree that Club, Club Officials, or Other Club Members may, without our permission and/or compensation to us, use, publish, and/or distribute any such photographic or video records for any Club related use, including, but not limited to, Club promotions, Club or other Land Rover or off-road newsletters or web sites, and/or litigation or claims involving the Club, Club Officials, and/or Other Club Members; provided that such use, publication and/or distribution is not for commercial purposes (i.e., where the Club, Club Officials, and/or Other Club Members is paid a fee or other monetary compensation that exceeds reimbursement for out-of-pocket costs incurred for that use, publication, or distribution.)

**9. Effect and Reaffirmation.** Regardless of our membership status (e.g., current or expired), this Agreement will legally bind each of us from the date we sign it until the Club actually receives a signed written notice that we terminate it. Any such termination will apply to all of us prospectively, but will not relieve any of us from any obligations arising before the Club’s actual receipt of our written termination notice. The Club and Club Officials may rely on this Agreement for each Event we (or any of us) elect to attend or participate in. The Club or Club Officials may, but are not required to, require us to sign a document reaffirming this Agreement as a condition to our right to attend or participate in an Event. This Agreement will survive any expiration or earlier termination of our Club membership until terminated in the manner set forth in this paragraph.

**10. General.** Neither we, nor any Club Official may modify the Agreement orally or in writing, except by a written amendment authorized in advanced by resolution of the Club’s Board of Directors. This Agreement is governed by the laws of California and supersedes all prior or contemporaneous written or oral agreements between the Club and any of us. If a court finds any provision of this Agreement invalid or unenforceable to any extent, the remainder of this Agreement shall not be affected. We agree to pay all legal fees and expenses incurred by the Club to interpret and/or enforce this Agreement.
